A copy of this permit must be kept readily available at the site of the work at all times.

All work shall be done in accordance with the County's Code and development standards and to the satisfaction of Pasco County					

- The applicant/property owner shall notify the County at least one day prior to commencement of construction.
- 3. All materials and equipment shall be subject to inspection by Pasco County.
- 4. During construction all safety regulations of the Florida Department of Transportation shall be observed and the applicant/property owner shall relieve Pasco County of all responsibility from damage of any nature arising from this permit. Subject to the same terms and conditions, the permit holder shall take such safety measures, including placing and display of caution signs, as it may deem necessary in conduct of construction and maintenance work hereunder.
- After issuance of permit, the Applicant/Property Owner is still subject to the County's authority to revoke or modify including the closing of such connection in order to protect safety and traffic operations on the respective right of way until the County deems the operations safe.
- If the use of the right of way deviates significantly from the original scope of work proposed, County may modify or revoke the permit. If after reasonable attempts by the County to resolve the deviations with no result, the County shall terminate the permit, and the County shall have the right to complete the work and to charge the Applicant/Property Owner for all costs incurred.
- 7. All property (including County property) disturbed by this permit must be restored to its original condition by owner as far as practical, subject to approval by Pasco County.
- 8. A sketch (two copies) covering the details of this installation shall be made a part of this permit. This permit is granted based upon the representation of the Applicant that he has notified all other utility users in the area covered by the permit and takes full responsibility for any damage incurred by prior installations as a result of these operations. The applicant/property owner takes full responsibility for notifying any and all utility or underground users of these proposed operations in order that they may safeguard their interest(s).
- It is expressly stipulated that this permit is a license for permissive use only and that the placing of facilities upon property or other construction pursuant to this permit shall not create or to vest any property right to the Applicant/Property owner.
- Whenever Pasco County decides to further exploit the rights of way, subject to this permit, any or all of said construction poles, wires, pipes, cables or other facilities and appurtenances authorized hereunder, shall be immediately removed from said rights of way, or reset or relocated thereon as required by Pasco County at the expense of Applicant/Property owner.
- The Applicant/Property Owner shall indemnify, defend and hold harmless Pasco County and all of its agents and employees from any and all damages, claims, costs, loss, change or expense, including attorney's fees and costs that may arise by reason of the construction, maintenance and operation of the driveway subject to this permit.
- The holder shall complete the requested work within 180 days or this permit shall become null and void
